ELIGIBILITY

The Destination Okeechobee Perform In Paradise Contest ("Contest") is open only to natural persons who are legal residents of the state of Florida who have a valid social security number, who are at least eighteen (18) years of age at the time of entry, who have a valid Soundcloud or Spotify account, who will be available to perform at the market showcase selected at time of entry (and as set forth below) and who will be in the Okeechobee, FL area March 5 through March 8, 2020 and available to perform at Okeechobee Music and Arts Festival in Sunshine Grove if selected as a winning band. VOID IN PUERTO RICO, U.S. VIRGIN ISLANDS, AND OTHER U.S. TERRITORIES AND POSSESSIONS, AND WHEREVER PROHIBITED OR RESTRICTED BY LAW. Contest may only be entered from and in eligible jurisdictions. Contest Entities, prize providers, and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, and the immediate family (spouse, parents, siblings, and children) and household members of each such person are not eligible to participate or win any prize. In the event of a dispute as to the identity of an entrant, the authorized account holder of the account will be deemed to be the entrant. CONTEST PERIOD

Administrator's computer is the official time keeping device of the Contest.

The Submission Period begins at 12:00 PM Eastern Time ("ET") on December 11, 2019 and ends at 11:59 PM ET on December 27, 2019.

The Round One Judging Period begins at 12:00 AM ET on December 28, 2019 and ends at 11:59 PM ET on January 2, 2020 ("Round One").

The Round Two Judging Period will take place at the showcase events tentatively scheduled to take place during period between January 20, 2020 and February 17, 2020, subject to change ("Round Two"). Judging will take place during each of the events in accordance with the criteria outlined below. Tentative Florida showcase event locations are as follows, subject to change:

NOTE: In the event a showcase date is cancelled and cannot be rescheduled, the Round Two winner for the cancelled date(s) will be determined by a panel of judges using the same criteria applied in Round One.

HOW TO ENTER

There is one (1) way to enter:

Via Internet

Visit the Contest entry page located at https://a.pgtb.me/fpLX2R and complete the entry form to include selecting the one showcase market you wish to perform if selected as a Finalist, providing your Band's information, and providing the Soundcloud or Spotify link to your Band's video or audio recording of the one (1) song ("Song") you wish to submit as your entry for the judges. Song shall include may not exceed three (3) minutes. Judges will apply the criteria to the first three minutes only if Song exceeds three (3) minutes. Song must be submitted via Soundcloud or Spotify link. Band Contact shall be a member of Band and must be the registered subscriber of the email account provided in the Contest entry Submission form. Bands must be able to perform at the showcase event selected at the time of entry if selected as a winning band.

If you do not have Soundcloud or Spotify account, visit www.soundcloud.com and/or www.spotify.com to register for free. Registration for and use of the Soundcloud and Spotify platforms are subject to their respective terms and conditions, and Promotion Entities have no responsibility with respect to such registration or use of the platforms. Promotion Entities are not responsible for the functionality of the Platforms, including changes that may interfere with the Promotion or the ability of a potential entrant to participate in the Promotion.

Each Band is eligible to submit up to one (1) Contest entry during the Contest Period, regardless of method or combination of methods of entry or number of entries submitted. Multiple entrants are not permitted to share the same email address or other relevant account. Any attempt by you to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void your entries and you may be disqualified. Use of any repetitive, automatic, programmed or similar technology, system or agent (including without limitation promotion entry service) to enter is prohibited and will void all of your entries. PRIZES

Six (6) Prizes consisting of a thirty (30) minute performance slot at Okeechobee Music and Arts Festival at Sunshine Grove in Okeechobee, FL scheduled to take place on March 5 through March 8, 2020. Stage, performance date and time slot to be determined at Contest Entities sole discretion. Each band member will receive an artist credential, not to exceed eight (8). Each Band will receive one (1) camping spot and parking for one (1) automobile per four Band members, not to exceed two (2) spots/parking. Band members must abide by all festival and venue policies. **Backline, camping gear, power/electricity, additional parking, travel and hotel accommodations are not included and are the sole responsibility of winner.** Contest Entities reserve the right to not award any prize to, or to revoke full or partial prize from, any band/band member who Contest Entities and/or venue personnel deem may, in their sole discretion, be intoxicated, be a safety risk, have violated any venue policy or law, and/or may bring Contest Entities into disrepute. The prize is non-transferable and resale of tickets is prohibited. Approximate Retail Value of each Prize is: Three Hundred Dollars (\$300).

Odds of winning the prize depends on the number of eligible entries received during the Contest Period. There will be only one prize per winner. Lost or stolen prizes will not be replaced. The prize does not include any other item or expense not specifically described in these Official Rules, and any such additional items or expenses are the sole responsibility of winner. Prizes may not be transferred or assigned. Only listed prizes will be awarded and no other prizing or substitutions will be made. SELECTION AND VERIFICATION OF POTENTIAL WINNERS

Administrator will select one (1) potential Round One winner, and a minimum of five (5) and a maximum of seven (7) potential finalists for each of the five (5) showcase events as described above, from all eligible entries on or around January 2, 2020. Potential Round One winner and the potential finalists will be notified on or about January 3, 2020. Eligible entries received during the Submission Period will be judged as set forth below.

During Round One, each eligible Song will be judged on the basis of the following criteria as applied to the Song: 30% originality, 30% musicianship, and 30% professional sound, and the Band's online presence: 10% quality of content and fan engagement. The Band with the highest overall score will automatically receive a performance slot at Okeechobee Festival. A minimum of five (5) and a maximum of seven (7) Bands from each of the five (5) participating showcase markets (each a "Market") will be selected from the Round One Judging Period to advance to Round Two. The Bands advancing to Round Two shall be the five (5) to seven (7) Bands ("Finalists") in each Market that receive the five (5) to seven (7) highest overall scores from all remaining eligible entries, as determined by judge(s). During Round Two, the Finalists will perform at their Market showcase and will be judged on a ten (10) point scale for each of the following criteria: Musicianship, Stage Presence, Originality, and Audience response.

The one (1) Band at each showcase event in Round Two that receives the highest overall score from among the Finalist Bands performing will be deemed to be one (1) of the winners. Administrator's decisions as to the administration and operation of the Promotion and the selection

of potential winners are final and binding in all matters related to the Promotion. In the event of a tie, Administrator will add and average the scores from the Round One Judging Period and the Final Showcase Judging Period to determine winning Band. Administrator's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Administrator reserves the right to disqualify any participant or winner and may refuse to award any prize to a person who is ineligible or has violated any rule, gained unfair advantage in participating in the Promotion, or obtained winner status using fraudulent or illegal means.

All potential finalists, or winners are subject to verification by Administrator. Administrator will not accept screen shots or other evidence of winning in lieu of its validation process. Potential winners must continue to comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. Each potential winner will be notified by email, phone, or direct message to the social account, as applicable.
